DIRECTIONS to John C. Land Landing

Turn off I-95 on exit 115 and head south on US-301 (toward Summerton) for 1 mile. Turn Left on J.W. Carter Road for 3 miles. Turn left at Moore's Texaco on road behind store (M.W. Rickenbaker Road) for 4.8 miles. Turn right on Greenall for 3 miles to the landing.

RULES
